#### RESULTS

Due to an insufficient amount of quantifiable DNA, PCR testing was not performed on the swab of the rear door of the suspect's truck (02). The DNA profile obtained from the swabbing of the front, bottom portion of the "Polo Ralph Lauren" hoodie matches the profile obtained for Austin Wages.

## FR08-0088-05.03.2

The DNA profile obtained from the swabbing of the bottom, right leg of the jeans matches the profile obtained for Austin Wages.
